

SWNA BOARD MEETING MINUTES September 7,2023

- I. Call to Order The meeting was called to order at 6:00 p.m. Bob appointed himself to take meeting minutes.
- II. Meeting Minutes David motioned to approve the July 6, 2023 meeting minutes; second by Will. Motion passed unanimously.

A. Guest Presentations

- a. Makayla Oliver, Community Relationship Manager, City of Bend, shared best practices, resources available and how she might assist our District. Key points made by Makayla:
 - 1. Review of the charter of the districts, their independence & funding thru grants from the City.
 - 2. Importance of communication & community events for residents & City Council.
 - 3. Importance of the Board being apolitical and serve as conduit of info between City & residents.
 - 4. There are two full time Bend Community Relationship managers to assist the districts.
 - 5. Assistance getting questions answered, surveys, organizing community events, arranging community trailers, arranging speakers for town halls, budgeting are some of the most notable services from the above said manager.
 - 6. City requirements:
 - a. Annual compliance form (completed for 2022)
 - b. Annual meeting
 - c. Land Use Chair to notify of projects in the neighborhood & the Master Plans for all of Bend
 - d. Meetings to be open to public & minutes taken
 - e. Survey once per year
 - 7. Monthly neighborhood newsletter authored by Makayla covering recent news & upcoming events, changes, etc
 - 8. Townhalls proposed by SWN were discussed.
 - a. Transportation Utility Fee (TUF) likely Oct or Nov
 - b. E-Bikes pending City & School progress
 - c. Tree Regulation Update Advisory Committee (TRUAC) following check-in with Council
 - 9. Makayla & Con Fischer, our Treasurer, to meet next week to discuss grants, special grants, typical costs for Districts (events, etc)

TUF will be first with the Mayor, while eBike & TRUAC await Council meetings to clarify their positions. We are looking to dates & trying to line up venue options.
